

Please read the End User Licence Agreement below before installing and using FlexiWriteTM.

To instal FlexiWriteTM, drag the program file (.exe, .app, .jar etc) to your applications or programs folder. You may instal the program in a different directory if you do not have administrator privileges. Please note that in Windows the application is not automatically added to the Start menu. Please launch it by double clicking it in the programs folder or other location where you installed it.

To open a document in FlexiWriteTM, click File > Open, click Open, or use the appropriate keyboard shortcut from within the application. Double clicking the document icon will NOT open the file.

FLEXIWRITETM END USER LICENCE AGREEMENT (EULA)

In this document 'You' and 'Your' shall refer to the person downloading and/or installing and/or using FlexiWriteTM. 'We', 'Us' and 'Our' shall refer to Samuel Green, or such entity as takes on Samuel Green's interest in FlexiWriteTM with his permission. FlexiWrite and FlexiWriteTM shall refer to the software application. Where FlexiWrite and FlexiWriteTM are used to refer to Samuel Green and his employees and agents concerned with the business of developing, promoting, and distributing FlexiWriteTM (the application), this will be made clear in the document.

By installing and using FlexiWriteTM you agree to the terms of this EULA. If you do not agree to these terms, you must stop using FlexiWriteTM and remove all copies of it from your device. We reserve the right to withdraw your right to use FlexiWriteTM should you breach any of the terms contained in this EULA. In such circumstances you must stop using FlexiWriteTM immediately and remove all copies of it from your device.

FlexiWriteTM is licensed, not sold, under the terms of this agreement. We retain all intellectual property rights to FlexiWriteTM, including but not limited to Copyright of the source code, title, and trademarks.

You are granted the non-exclusive, non-transferable right to install and use one copy of FlexiWriteTM on one device. FlexiWriteTM may be used by more than one individual on that device, providing each individual has access to this EULA. Each user's use of FlexiWriteTM shall be in accordance with the terms of this EULA. You may not modify, edit, copy portions of, or attempt to reverse engineer or access the source code of FlexiWriteTM. You may not make available for download or otherwise re-distribute FlexiWriteTM to the public. You may provide individual copies of FlexiWriteTM to other individuals, or copy FlexiWriteTM to additional devices which you own, only in the following limited circumstances: 1) The device on which FlexiWriteTM is to be installed does not connect to the

internet or; 2) The device on which FlexiWrite™ is to be installed connects to the internet but it would be prohibitively expensive or time consuming to download FlexiWrite™ onto the device owing to the nature of the device's internet connection or; 3) It is not possible to download FlexiWrite™ onto the device owing to temporary network problems, problems with our servers or those of our agents, or for other technical reasons. In all other circumstances an additional copy of FlexiWrite™ must be obtained from us or our agents. When providing copies of FlexiWrite™ to individuals under the terms above, you may not represent yourself as the developer of FlexiWrite™ or our agents, and you may not represent FlexiWrite™ as your work; you must only provide the complete, unmodified package with its original filename, for example flexiwrite-eng-mac.dmg or flexiwrite-eng-win.zip. If you are provided with a non-release version of FlexiWrite™, e.g. by email, this is to be treated as confidential. If we release or otherwise provide updates or updated versions of FlexiWrite™, this EULA shall also apply to the updates or updated versions, unless the updates or updated versions are provided with their own EULA. Under such circumstances the new EULA shall supersede this EULA for the update, the updated version, or if stated in that EULA the updated copy of FlexiWrite™ on your device.

Some versions of FlexiWrite™ are provided with the Java Runtime Environment (JRE). Use of these versions is also subject the Oracle Binary Code Licence Agreement (BCL). Intellectual property rights to the Java Runtime Environment are held by Oracle. Samuel Green and his employees and agents do not develop, maintain, or make any claim to intellectual property rights to the JRE.
